# **VIDEO CONTEXT**

Judith Heumann's moving talk addresses the progress made in securing civil rights for people with disabilities through the lens of her own life story. She takes us from her childhood where she faced impediments to attending elementary school to her advocacy as a leader in the Disability Rights Movement. Throughout, she stresses the importance of being one's own advocate as well as finding like minded individuals when looking to achieve positive change. She ends her talk by reminding us that despite all that has been accomplished in the United States, there is still more to do both in the United States and around the world.

#### KEY VOCABULARY

**Disability** – A physical, mental, cognitive, or developmental condition that impairs, interferes with, or limits a person's ability to engage in certain tasks or actions or participate in typical daily activities and interaction.

**Discrimination -** A prejudiced or prejudicial outlook, action, or treatment.

**Board of Education -** An official group of citizens controlling the elementary and secondary public-school education in a state, county, city, or town.

Reasonable Accommodation -Something done to accommodate a disabled person that does not jeopardize safety or pose an undue hardship for the individual or group doing it.

Activism - A doctrine or practice that emphasizes direct vigorous action especially in support of/or opposition to one side of a issue
